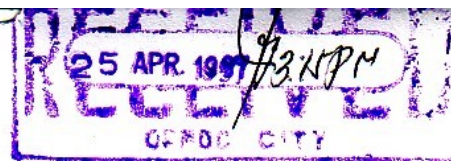
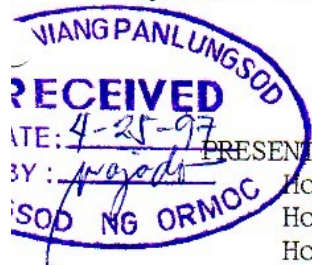

RESOLUTION NO. 97-70

A RESOLUTION RESPECTFULLY REQUESTING THE COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICER, MR. RAMON N. CALUMBAY, ALBUERA, LEYTE, TO CONDUCT SOONEST THE FINAL RELOCATION SURVEY OF THE POLITICAL BOUNDARY BETWEEN THE CITY OF ORMOC AND THE MUNICIPALITY OF KANANGA, LEYTE, AND TO INFORM THIS SANGGUNIAN OF THE RESULT THEREOF.

WHEREAS, the political boundary conflict between the City of Ormoc and the Municipality of Kananga, Leyte, has been pending for quite sometimes;

WHEREAS, this controversy has been brought to the attention of the Lands Management Service, Department of Environment and Natural Resources, Region VIII, Tacloban City, which on October 17, 1995, initiated a meeting of the City Officials of Ormoc and the Municipal Officials of Kananga, Leyte, for the purpose of settling the same; but unfortunately, notwithstanding the lapse of a sufficient material time, said Office has not resolved said controversy;

WHEREAS, yesterday, April 23, 1997, the Chairman, Committee on Public Properties, together with the Honorable City Vice Mayor, and the Chairman, Committee on Environment, went to the Office of the Community Environment and Natural Resources (CENRO) at Albueria, Leyte, to seek



assistance for the early settlement of the boundary conflict between the City of Ormoc and the Municipality of Kananga, Leyte, and its Officer Incharge, Mr. Ramon N. Calumbay, suggested that we put our request in writing for a final relocation survey of the political boundary between the two LGUs;

WHEREFORE, foregoing premises considered, on MASS MOTION of the Body and OVERWHELMING SECONDS, so be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION RESPECTFULLY REQUESTING THE COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICER, MR. RAMON N. CALUMBAY, ALBUERA, LEYTE, TO CONDUCT SOONEST THE FINAL RELOCATION SURVEY OF THE POLITICAL BOUNDARY BETWEEN THE CITY OF ORMOC AND THE MUNICIPALITY OF KANANGA, LEYTE, AND TO INFORM THIS SANGCUNIAN OF THE RESULT THEREOF;

ENACTED, April 24, 1997.

Cleto L. Evangelista, Jr., and all other Offices concerned;
