WHEREAS, this Sanggunian is in receipt of a letter dated 2 May 1997 from Engr. Ramon C. Omega, District Engineer, Leyte Fourth Engineering District, this city, of the aforementioned infrastructure projects for 1997 with corresponding Programs of Work and Detailed Estimates for approval of the same;

WHEREAS, of significance to state in here is City Ordinance No. 53 s. 1995 entitled "AN ORDINANCE IMPLEMENTING THE PROVISION OF THE LOCAL GOVERNMENT CODE OF 1991 (R.A. 7160) REQUIRING MANDATORY COORDINATION AND CONSULTATION WITH THE APPROPRIATE LOCAL GOVERNMENT UNITS, NON-GOVERNMENTAL AND PEOPLE'S ORGANIZATION AND OTHER CONCERNED SECTORS, AND APPROVAL OF THE SANGGUNIANG PANLUNGSOD NG ORMOC PRIOR TO THE IMPLEMENTATION OF NATIONALLY FUNDED PROJECTS/PROGRAMS AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF", and Section 1 thereof has required "Prior Coordination, Consultation and Approval of the Sangguniang Panlungsod ng Ormoc in the Implementation of Nationally Funded Projects/Program within the territorial jurisdiction of the City of Ormoc";

WHEREAS, this august Body, through the representation of the Honorable Chairman, Committee on Infrastructures, has considered the aforesaid request of the District Engineer, Leyte Fourth Engineering District, this city, meritorious and reasonable, hence, must be accorded with due course of action;

WHEREFORE, premises considered, on motion of Kagawad Claudio P. Larrazabal, Chairman, Committee on Infrastructures, severally seconded by Kagawad Deborah Robin B. Conejos, Benjamin B. Lladoc and Gregorio A. Yrastorza, Jr.; be it

2. CONSTRUCTION OF HIGHWAY JUNCTION TO AIRPORT ROAD - P4.00 M
