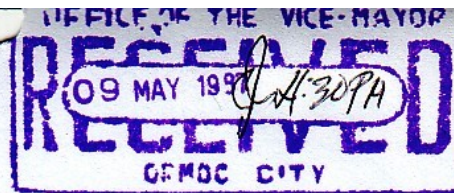
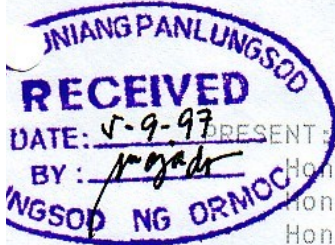

RESOLUTION NO. 97-80

A RESOLUTION INTERPOSING NO OBJECTION TO THE PROPOSED
AGRO-INDUSTRIAL BUILDING (RICE MILL AND WAREHOUSE) OF
ORMOC MILLING COMPANY MANAGED BY MELCHOR Q. SIA, LOCAT-
ED AT BARANGAY DAYHAGAN, ORMOC CITY, AND ENDORSING THE
SAME TO THE DEPARTMENT OF ENVIRONMENT AND NATURAL
RESOURCES (DENR).

WHEREAS, this Sanggunian is in receipt of a letter dated 30 April
1997 from Mr. Melchor Q. Sia, Manager, Ormoc Milling Company, requesting
for a resolution endorsing the Proposed Agro-Industrial Building (Rice
Mill and Warehouse) of said Milling Company located at Brgy. Dayhagan,
this city as one of the requirements for the issuance of Environmental
Clearance Certificate (ECC) from the Department of Environment and
Natural Resources, Tacloban City;

WHEREAS, based on the documents and other papers submitted, this
august Body has found out that said project has been issued a Certifi-
cate of Zoning Compliance by the Deputized Zoning Administrator dated 25
November 1996;
