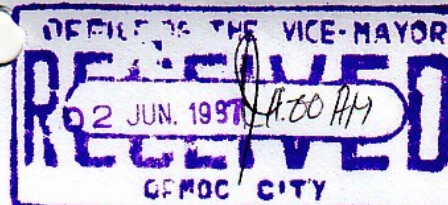
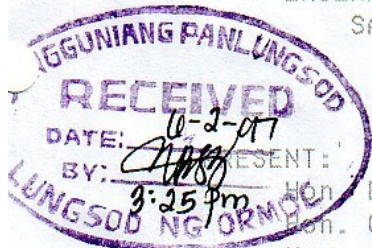

ENACTED, May 29, 1997.


RESOLVED, FURTHER, to furnish copies of this resolution, each to


