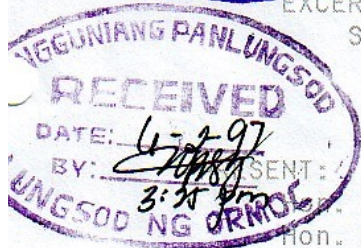

A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION FOR COMPLEX SUBDIVISION PROJECT OF MR. ROLANDO BAUTISTA, ET AL COMPRISING LOT NO. 2344, 2345 CAD. 256, ORMOC CADASTRE AND LOT 2347-A-1-E, PSD-08-008926-D LOCATED AT BARANGAY PUNTA, ORMOC CITY, WITH A TOTAL PROJECT AREA OF 22,669 SQ. METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NOS. 30182, 20358 AND 29767 CONTAINING 17 SUBDIVISION LOTS EXCLUDING ROAD LOTS AND LEGAL EASEMENT.

PRESENTED for consideration by this august Body is the following:

An Application for Complex Subdivision Project of Mr. Rolando Bautista, et al, comprising Lot No. 2344, 2345 cad. 256, Ormoc Cadastre and Lot 2347-A-1-E, Psd-08-008926-D located at Barangay Punta, this city, with a total project area of 22,669 sq. meters covered by Transfer Certificate of Title Nos. 30182, 20358 and 29767 containing 17 subdivision lots excluding road lots and legal easements.

WHEREAS, this august Body has found out that the site of said proposed complex subdivision project was duly inspected and the documents submitted have shown that said proposed project is within Industrial Use as per approved Urban Land Use Plan of this city and that the subdivision project among co-owners is in accordance with the implementing rules and regulations, hence, this Sangguniang interposes no objection for the same;
