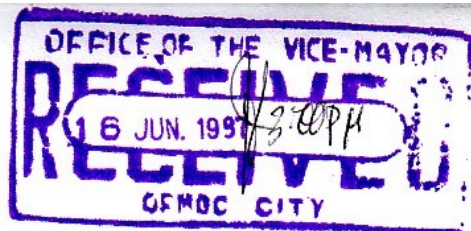

A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION FOR COMPLEX SUBDIVISION PROJECT OF THE HEIRS OF CLETO P. EVANGELISTA INVOLVING LOT NO. 5282-A-2 PSD-08-003389 LOCATED AT BARANGAY SAN ISIDRO, ORMOC CITY, WITH A TOTAL PROJECT AREA OF 18,606 SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 20778 CONTAINING ELEVEN (11) SUBDIVISION LOTS EXCLUDING ROAD LOTS.

PRESENTED for consideration by this august Body is the following:

An Application for Complex Subdivision Project of the heirs of Cleto P. Evangelista involving Lot No. 5282-A-2 Psd-08-003389 located at Brgy. 
