

A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION FOR COMPLEX SUBDIVISION PROJECT OF ENRIQUE AVILES ET. AL., COMPRISING LOT NO. 1649-C, PSD-74890 AND LOT NO. 1649-D-4, (LRC) PSD-173326 LOCATED AT BARANGAY BANTIGUE, ORMOC CITY, WITH A TOTAL PROJECT AREA OF 42,555 SQ. METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NOS. 30044 AND 30126 CONTAINING 13 SUBDIVISION LOTS EXCLUDING ROAD LOTS.

PRESENTED for consideration by this august Body is the following:

An Application for Complex Subdivision Project of Enrique Aviles et.al., comprising Lot No. 1649-C, Psd-74890 and Lot No. 1649-D-4, (LRC) Psd-173326 located at Barangay Bantigue, Ormoc City, with a total project area of 42,555 sq. m. covered by Transfer Certificate of Title Nos. 30044 and 30126 containing 13 subdivision lots excluding road lots.

WHEREAS, this august Body has found out that the site of said proposed complex subdivision project was duly inspected and the documents submitted have shown that said proposed project is within Barangay Built-up Areas (BBA) residential use as per Zoning Certification issued by Engr. Dario D. Sarit, Deputized Zoning Administrator dated 5 May 1997 under Zoning Ordinance, this city, and that the said subdivision project among co-owners is in accordance with the provision of P.D. 957, E.O. 648 and R.A. 7160 and its Implementing Rules and Regulations, hence, this Sanggunian interposes no objection for the same;
