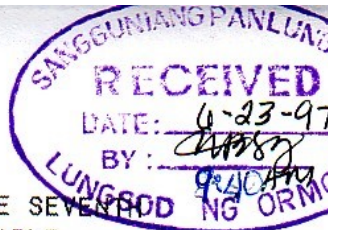

RESOLUTION NO. 97-109

A RESOLUTION SUPPORTING RESOLUTION NO. 97-085 OF THE SANGGUNIANG PANLALAWIGAN OF ILOILO, ENTITLED: "A RESOLUTION REQUESTING THE COMMISSION ON HIGHER EDUCATION TO DEFER OR DELAY THE PHASING DOWN OF ENROLLMENT IN THE HIGH SCHOOL DEPARTMENTS OF CHED-SUPERVISED EDUCATIONAL INSTITUTIONS".

WHEREAS, this Sanggunian is in receipt of Resolution No. 97-085 of the Sangguniang Panlalawigan of Iloilo, entitled, "RESOLUTION REQUESTING THE COMMISSION ON HIGHER EDUCATION TO DEFER OR DELAY THE PHASING DOWN OF ENROLLMENT IN THE HIGH SCHOOL DEPARTMENTS OF CHED-SUPERVISED EDUCATIONAL INSTITUTIONS";

WHEREAS, the Honorable Members of the 7th Sangguniang Panlungsod in Session, have conformed to the propriety of said Resolution No. 97-085 which reasonably cited that "it is a constitutional mandate for the state to provide free elementary and secondary education to the Filipino Youth and the phasing down policy of CHED of the high school enrollment in polytechnic and other CHED-Supervised schools will deprive thousands of young Filipinos to have free access to secondary educations";

NOW, THEREFORE, on motion of Kagawad Benjamin B. Lladoc, Chairman, Committee on Education, severally seconded by mga Kagawad Claudio P. Larrazabal, Deborah Robin B. Conejos, Alfredo F. Capahi and Chiqui B. Labagala; be it
