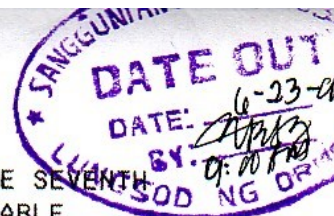
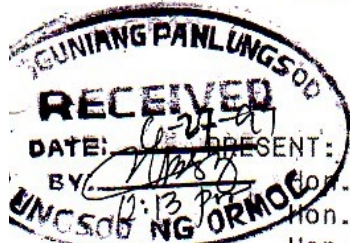

RESOLUTION NO. 97-110

A RESOLUTION RESPECTFULLY REQUESTING THE CHIEF OF STAFF, ARMED FORCES OF THE PHILIPPINES, CAMP GENERAL EMILIO AGUINALDO, QUEZON CITY, TO ACT FAVORABLY ON OUR SP RESOLUTION NO. 97-55, ENTITLED: "A RESOLUTION STRONGLY AND FAVORABLY ENDORSING TO HIS EXCELLENCY, PRESIDENT FIDEL V. RAMOS, THE WITHIN RESOLUTION NO. 6, SERIES OF 1997, OF THE SANGGUNIANG BARANGAY OF BRGY. CAMP DOWNES, THIS CITY, ENTITLED: "A RESOLUTION EARNESTLY REQUESTING THE CITY MAYOR, HON. EUFROCINO M. CODILLA, SR., THRU THE SANGGUNIANG PANLUNGSOD NG ORMOC, TO ENDORSE THE ATTACHED PETITION OF THE BARANGAY CAMP DOWNES RESIDENTS' ASSOCIATION MOST RESPECTFULLY REQUESTING HIS EXCELLENCY, PRESIDENT FIDEL V. RAMOS, TO SEGREGATE AND RECLASSIFY A PORTION OF CAMP DOWNES MILITARY RESERVATION, SPECIFICALLY NINE (9) HECTARES THEREOF, INTO A RESIDENTIAL AREA SO AS TO ESTABLISH SEPARATE TERRITORY FOR BARANGAY CAMP DOWNES AND LOTS THEREIN TO BE AWARDED TO ACTUAL RESIDENT", WHICH WAS ENDORSED TO THAT OFFICE FOR APPROPRIATE ACTION.

WHEREAS, this Sanggunian has been furnished a copy of the letter of Assistant Secretary for Installations & Logistics, Cesar H. Bello Ceso II addressed to Mayor Eufrocino M. Codilla, Sr., a photocopy of which is hereto attached for ready reference;

WHEREAS, from the aforementioned letter, it can be gleaned that Resolution No. 97-55 of this Sanggunian has been referred to the Chief of Staff, Armed Forces of the Philippines, Camp General Emilio Aguinaldo, Quezon City, for appropriate action;

WHEREAS, the petitioning residents of Brgy. Camp Downes, this City, have been occupying this portion of the military reservation (Camp Downes) for a very long time now by building their residential homes, and raising their families thereat; hence, it can be rightfully and correctly presumed that this portion of the military reservation is no longer needed by our military authorities, and can now be appropriately released as such; so that the actual occupants thereat who are mostly families of military servicemen, former military servicemen, and war veterans, be considered as rightful owners of the lots they are now occupying;

WHEREFORE, on MASS MOTION of the Body and with OVERWHELMING SECONDS, so be it

RESOLVED, to pass a resolution RESPECTFULLY REQUESTING THE CHIEF OF STAFF, ARMED FORCES OF THE PHILIPPINES, CAMP GENERAL EMILIO AGUINALDO, QUEZON CITY, TO ACT FAVORABLY ON OUR SP RESOLUTION NO. 97-55, ENTITLED: "A RESOLUTION STRONGLY AND FAVORABLY ENDORSING TO HIS EXCELLENCY, PRESIDENT FIDEL V. RAMOS, THE WITHIN RESOLUTION NO. 6, SERIES OF 1997, OF THE SANGGUNIANG BARANGAY OF BRGY. CAMP DOWNES, THIS CITY, ENTITLED: "A RESOLUTION EARNESTLY REQUESTING THE CITY MAYOR, HON. EUFROCINO M. CODILLA, SR., THRU THE SANGGUNIANG PANLUNGSOD NG ORMOC, TO ENDORSE THE ATTACHED PETITION OF THE BARANGAY CAMP DOWNES RESIDENTS' ASSOCIATION MOST RESPECTFULLY REQUESTING HIS EXCELLENCY, PRESIDENT FIDEL V. RAMOS, TO SEGREGATE AND RECLASSIFY A PORTION OF CAMP DOWNES MILITARY RESERVATION, SPECIFICALLY NINE (9) HECTARES THEREOF, INTO A RESIDENTIAL AREA SO AS TO ESTABLISH SEPARATE TERRITORY FOR BARANGAY CAMP DOWNES AND LOTS THEREIN TO BE AWARDED TO ACTUAL RESIDENT", WHICH WAS ENDORSED TO THAT OFFICE FOR APPROPRIATE ACTION;

Codilla, Sr., City Mayor, Ormoc City; the Honorable Punong Barangay, Brgy. Camp Downes, Ormoc City, and other Offices concerned;


