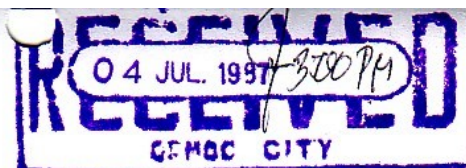

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A DEED OF DONATION, COPY OF WHICH IS HERETO ATTACHED, IN FAVOR OF THE BUREAU OF INTERNAL REVENUE (BIR) REPRESENTED BY ITS REGIONAL DIRECTOR JAIME B. SANTIAGO.


