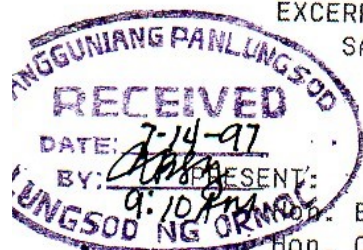
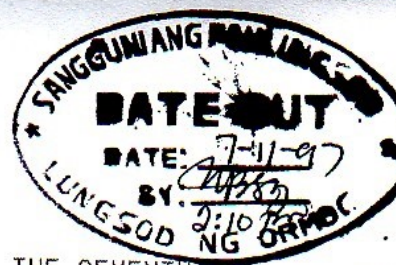

RESOLUTION NO. 97-119

A RESOLUTION REQUESTING ENGINEER DARLITO A. PAREJA, TAX MAPPER IV, CITY ASSESSOR'S OFFICE, THIS CITY, TO CONDUCT A TECHNICAL SURVEY IN ORDER TO IDENTIFY AND DELINEATE THE BOUNDARIES BETWEEN BARANGAY CAN-ADIENG AND BARANGAY CAMP DOWNES, AND TO FURNISH THE ABOVE STATED BARANGAYS THE RESULTS OF THE SAID SURVEY.

WHEREAS, this Sanggunian is in receipt of Resolution No. VIII s. 1997 from the Barangay Council of Barangay Can-adieng, this city, entitled, "A RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD NG ORMOC TO SETTLE THE EXISTING BARANGAY BOUNDARY DISPUTE BETWEEN BARANGAY CAN-ADIENG AND BARANGAY CAMP DOWNES, THIS CITY";

WHEREAS, "in order to settle the issue once and for all and to enable both barangays to determine their territorial jurisdiction" as stated in said resolution, this august Body has considered said request valid and reasonable, hence, must be given due course of action;

PAREJA, TAX MAPPER IV, CITY ASSESSOR'S OFFICE, THIS CITY, TO CONDUCT A TECHNICAL SURVEY IN ORDER TO IDENTIFY AND DELINEATE THE BOUNDARIES BETWEEN BARANGAY CAN-ADIENG AND BARANGAY CAMP DOWNES, AND TO FURNISH THE ABOVE STATED BARANGAYS THE RESULTS OF THE SAID SURVEY;
