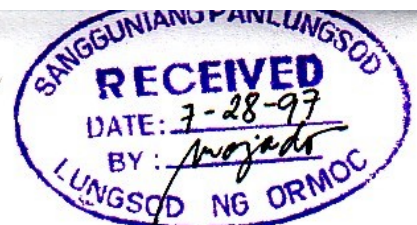

RESOLUTION NO. 97-129

A RESOLUTION ADOPTING RESOLUTION NO. 97-115 OF THE SANGGUNIANG PANLALAWIGAN OF ILOILO CITY, ENTITLED: "A RESOLUTION OPPOSING THE APPROVAL OF HOUSE BILL NO. 8358, GRANTING FRANCHISE TO METROPOLITAN LEISURE AND TOURISM CORPORATION (MLTC) FOR THE OPERATION OF JAI-ALAI IN THE COUNTRY".

WHEREAS, this august Body is in receipt of Resolution No. 97-115 from the Sangguniang Panlalawigan of Iloilo, Iloilo City, entitled: "RESOLUTION OPPOSING THE APPROVAL OF HOUSE BILL NO. 8358, GRANTING FRANCHISE TO METROPOLITAN LEISURE AND TOURISM CORPORATION (MLTC) FOR THE OPERATION OF JAI-ALAI IN THE COUNTRY";

WHEREAS, as stated in said resolution that "if Jai-Alai frontons are established in all our major cities and betting stations in all major towns, gambling will become one of our largest industries and preoccupations";
