RESOLUTION SUPPORTING THE REQUEST OF BARANGAY STO. NINO TO REQUIRE PASSENGER VEHICLES PLYING THE ORMOC - STO. NINO ROUTE TO OBSERVE THE PROPER FARE RATES AS APPROVED BY THE LIFRB IN CONNECTION WITH THE FRANCHISE.

WHEREAS, this Sanggunian is in receipt of Resolution No. 97-003 from the Barangay Council of Barangay Sto. Niño, this city entitled: "A RESOLUTION EARNESTLY REQUESTING THE SANGGUNIANG PANLUNGSOD OF ORMOC TO REPRESENT IN OUR BEHALF, WITH THE LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD (LTFRB), REGARDING THE EXCESSIVE FARES, JEEPNEYS PLYING OUR ROUTE ARE CHARGING":

WHEREAS, as stated in said resolution, passenger jeepneys plying said route before used to charge \$\mathbb{P}5.00\$ per passenger for a distance of 6.5 kms. from said barangay to the city proper, however, lately said jeepneys increased their fares to \$\mathbb{P}6.00\$ per passenger and \$\mathbb{P}4.00\$ for students causing numerous complaints from the commuters of said route, thus considered excessive, oppressive and detrimental to the growth of the economy by the Barangay Council of Sto. Ni\(\tilde{n}0\);

WHEREAS, the 7th Sangguniang Panlungsod ng Ormoc mindful of the plight of the residents as well as the commuters of said route, has considered said request valid and reasonable, hence must be given the necessary course of action;

WHEREFORE, premises considered, on motion of Kagawad Jose C. Alfaro, Jr., Chairman, Committee on Transportation and Communications, duly seconded by Kagawad Benjamin B. Lladoc; be it
