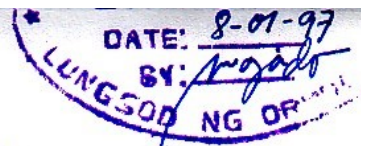

aforementioned mga Barangay of this city;

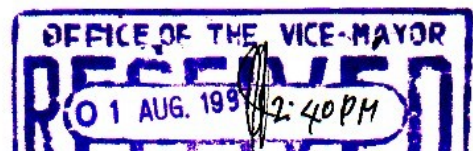
WHEREAS, based on the initial review of said budgets conducted by
