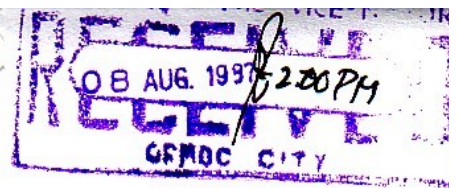
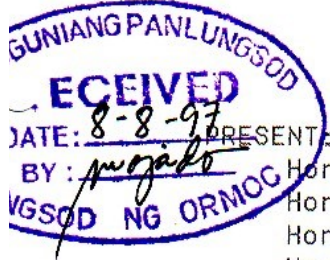

Conejos, Benjamin B. Lladoc and Chiqui B. Labagala; be it


RESOLVED, to pass a resolution APPROVING THE 1997 SUPPLEMENTAL


RESOLVED, FURTHER, to furnish copies of this resolution each to His
