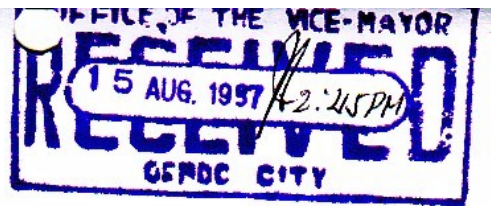
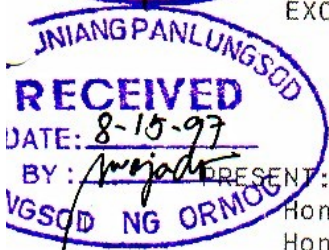

RESOLUTION NO. 97-144

A RESOLUTION ENDORSING AND SUPPORTING HOUSE RESOLUTION NO. 1281 OF THE HOUSE OF REPRESENTATIVES, INTRODUCED BY HONORABLE LEONARDO Q. MONTEMAYOR, ENTITLED: "RESOLUTION DIRECTING TO CONDUCT AN INVESTIGATION, IN AID OF LEGISLATION, INTO THE PLAN OF THE PHILIPPINE NATIONAL OIL COMPANY ENERGY DEVELOPMENT CORPORATION TO CONDUCT MINING EXPLORATION WITH THE LEYTE GEOTHERMAL RESERVATION AND THE MOUNT PANGASUGAN AND MOUNT BATO WATERSHED RESERVATION IN LEYTE PROVINCE.

WHEREOF, on MASS MOTION of the BODY and with OVERWHELMING SECONDS, so be it


