

NINO AND ADJACENT LOTOWNERS ARE SATISFIED.

- 2. Social Acceptance of Barangay Sto. Niño
- 3. Results of the Baseline Data Water Study conducted by the University of San Carlos at Dayhagan Creek and Culisao Creek.

WHEREAS, upon proper consultation with the residents of Barangay San Pablo, this city, same is socially accepted as manifested by the Barangay Council of San Pablo through Resolution No. 06 s. 1996 entitled "APPROVING AND ENDORSING THE ORMOC ROYALE ESTATES SUBDIVISION SITUATED AT BRGY. NINO AND ADJACENT LOT OWNERS ARE SATISFIED;
