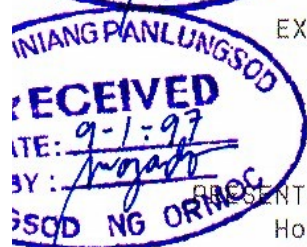
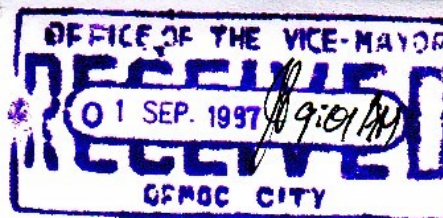



ENACTED, August 28, 1997.


