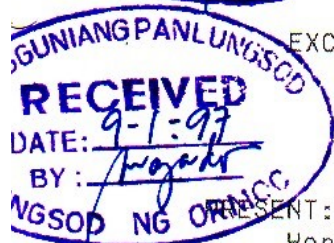
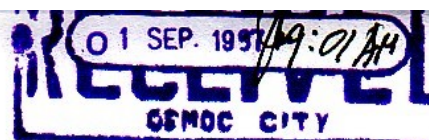

RESOLUTION NO. 97-151

A RESOLUTION EARNESTLY REQUESTING THE REGIONAL DIRECTOR,
CIRILO R. BALAGAPO, JR., DEPARTMENT OF AGRICULTURE,
REGIONAL FIELD OFFICE NO. 8, TACLOBAN CITY, TO CONDUCT
A TECHNICAL STUDY OF THE LIBONGAO RIVER FOR IRRIGATION
PURPOSES OF MORE OR LESS 100-200 HECTARES FOR BARANGAYS
MATICA-A AND DON POTENCIANO LARRAZABAL, THIS CITY, AND
TO ALLOCATE FUNDS FOR THIS PROJECT.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 18 August 1997 from the Honorable City Mayor of the letter of Mr. Edgardo C. Codilla, Chairman, City Agriculture & Fishery Council requesting this Sangguniang Panlungsod to pass a resolution requesting the Regional Director, Department of Agriculture, Regional Field Office No. 8, Tacloban City to conduct a technical study of the Libongao River for irrigation purposes of more or less 100-200 hectares for Brgy. Matica-a and Don Potenciano Larrazabal, and allocate funds for said project together with Resolution No. 02 s. 1997 from the Brgy. Council of Brgy. Don Potenciano Larrazabal entitled, "A RESOLUTION REQUESTING DEPARTMENT OF AGRICULTURE TO CONDUCT TECHNICAL, STUDY OF LIBONGAO RIVER TO IRRIGATE THE 100-200 HECTARES OF BARANGAY MATICA-A AND BARANGAY DON POTENCIANO LARRAZABAL";

WHEREAS, as stated in said Resolution No. 02 s. 1997 of Barangay Council of Don Potenciano Larrazabal, this city, said potential irrigable water can irrigate 100-200 hectares of vast fertile Agricultural land;

WHEREAS, this august Body in SESSION, has considered said request reasonable, hence, must be accorded with the necessary course of action;

WHEREFORE, premises considered, on motion of Kagawad Claudio P. Larrazabal, Chairman, Committee on Agriculture, duly seconded by Kagawad Benjamin B. Lladoc; be it

RESOLVED, to pass a resolution EARNESTLY REQUESTING THE REGIONAL DIRECTOR, CIRILO R. BALAGAPO, JR., DEPARTMENT OF AGRICULTURE, REGIONAL FIELD OFFICE NO. 8, TACLOBAN CITY, TO CONDUCT A TECHNICAL STUDY OF THE LIBONGAO RIVER FOR IRRIGATION PURPOSES OF MORE OR LESS 100-200 HECTARES FOR BARANGAYS MATICA-A AND DON POTENCIANO LARRAZABAL, THIS CITY, AND TO ALLOCATE FUNDS FOR THIS PROJECT;
