A RESOLUTION SUPPORTING THE STAND/POSITION PAPER OF THE ORMOC CITY TRAFFIC COMMAND TO DENY THE REQUEST OF THE ORMOC TRYCICAD DRIVERS AND OPERATORS ASSOCIATION TO LEGALLY OPERATE WITHIN THE MARKET AREA AND BACK ROADS WITHIN THE JURISDICTION OF ORMOC CITY.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 20 August 1997 from the Honorable City Mayor Eufrocino M. Codilla, Sr., of Resolution No. 2 s. 1997 of the Ormoc Trycicad Drivers & Operators Association, this city entitled, "RESOLUTION REQUESTING THE HONORABLE CITY MAYOR AND THE SANGGUNIANG PANLUNGSOD OF ORMOC CITY TO ALLOW THE TRYCICAD OPERATORS TO CONTINUE WITHIN THE ORMOC PUBLIC MARKET-TERMINAL AND BACK ROAD AND ADOPT AN ORDINANCE ALLOWING/LEGALIZING THE OPERATIONS OF THE TRYCICAD OPERATORS WITH PROPER BUSINESS PERMITS FROM THE CITY";
