

RESOLUTION NO. 97-153

A RESOLUTION ENDORSING TO THE LAND TRANSPORTATION FRANCHISING REGULATORY BOARD (LTFRB) THE APPLICATION OF NDD TRANSPORT CORPORATION FOR A FRANCHISE TO OPERATE TRANSPORTATION SERVICES ALONG THE LINES: CATARMAN-LILOAN VIA CALBAYOG-CATBALOGAN-TACLOBAN-CARIGARA-ORMOC-BAYBAY-MAASIN-SOGOD AND VICE VERSA, WITH THE USE OF TEN (10) NEW UNITS.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 20 August 1997 from the Honorable City Mayor Eufrocino M. Codilla, Sr., of the letter of Mr. Alberto S. Dadis, President, NDD Transport Corp., requesting favorable endorsement of said company's application for franchise to operate transportation services along the lines CATARMAN-LILOAN VIA CALBAYOG-CATBALOGAN-TACLOBAN-CARIGARA-ORMOC-BAYBAY-MAASIN-SOGOD and VICE VERSA, with the use of ten (10) new units;

WHEREAS, this august Body has considered said request valid and reasonable hence must be accorded with the necessary course of action;
