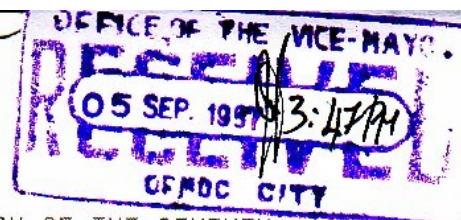

RESOLUTION NO. 97-158

A RESOLUTION APPROVING ORDINANCE NO. 97-001 S. 1997 OF
THE SANGGUNIANG BARANGAY OF BARANGAY DOLORES, THIS
CITY, ENTITLED: "AN ORDINANCE PROHIBITING ASTRAY
ANIMALS SUCH AS PIGS, GOATS, CARABAOS, COWS, AND HORSES
ROAMING AROUND THE BARANGAY PLAZA, SCHOOL PREMISES,
PUBLIC PLACES AND OTHER PLACES NOT HIS OWN PROPERTY
PROVIDING PENALTIES IN VIOLATION THEREOF".

WHEREAS, this Sanggunian is in receipt of Ordinance No. 97-001 s.
1997 of the Sangguniang Barangay of Barangay Dolores, this city,
entitled, "AN ORDINANCE PROHIBITING ASTRAY ANIMALS, SUCH AS PIGS, GOATS,
CARABAOS, COWS, AND HORSES ROAMING AROUND THE BARANGAY PLAZA, SCHOOL
PREMISES, PUBLIC PLACES AND OTHER PLACES NOT HIS OWN PROPERTY PROVIDING
PENALTIES IN VIOLATION THEREOF";

WHEREAS, it is the observation of this august Body that the
aforecited Ordinance has conformed to pertinent provisions of the Local
Government Code and consistent with city X X X ordinance and that the
required public hearing as mandated by Section 186 of R.A. 7160,
otherwise known as the Local Government Code of 1991, has been complied
with as certified by the Punong Barangay, hence, said ordinance is valid
and within the province of the Sangguniang Barangay of Barangay Dolores
to legislate;

Lladoc; be it
