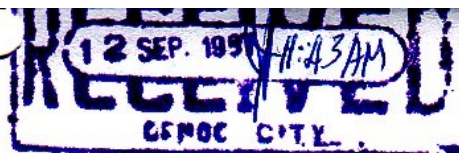


RESOLVED, AS IT IS HEREBY RESOLVED, to approve the 1997 Supplemental Budget No. 02 of Barangay District 14, this city;

ENACTED, September 11, 1997.


