

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. TO ENTER INTO A NEGOTIATED CONTRACT WITH PHILIPPINE RIGID CONSTRUCTION CORPORATION FOR THE CONSTRUCTION OF ORMOC CITY PUBLIC MARKET "BUILDING A" PHASE II, IN THE AMOUNT OF THIRTY MILLION PESOS (P30,000,000.00).

In view of Resolution No. 97-08-53 dated August 25, 1997 of the Pre-qualification Bids and Awards Committee (PBAC), copies of which are hereto attached with supporting documents for your ready reference, may I respectfully request that the undersigned be given authority to enter into a negotiated contract with Philippine Rigid Construction Corpora-

tion for the Construction of Ormoc City Public Market "Building A" Phase II, in the amount of THIRTY MILLION PESOS ONLY (P30,000,000.00).
