

APPROVING THE APPLICATION FOR SUBDIVISION PROJECT OF MR. PAUL R. TAN, LOCATED AT BARANGAY SAN PABLO, ORMOC CITY, INVOLVING LOT NO. 7, PCS-03-00070, WITH A TOTAL PROJECT AREA OF 1,162 SQ. METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. CONTAINING 3 SUBDIVISION LOTS EXCLUDING ROAD LOTS.
