LOCATED AT BARANGAY COGON, ORMOC CITY INVOLVING LOT NO. 3014-A-X, PSD-08008285-D, WITH TOTAL PROJECT AREA OF 2,066 SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 28865 CONTAINING 2 SUBDIVISION LOTS EXCLUDING ROAD LOTS.
