RESOLUTION NO. 97-169

RESOLUTION RETURNING TO THE SANGGUNIANG BARANGAY OF BARANGAY CABULIHAN, THIS CITY, ITS BARANGAY TAX ORDINANCE NO. 01 S. 1997, ENTITLED, "AN ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS, SIGNBOARD, BILLBOARDS, OTHER OUTDOOR ADVERTISEMENTS, CERTIFICATIONS, BARANGAY CLEARANCE AND . BARANGAY PERMITS.

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 01 1997, as aforecited, from the Sanggunian Barangay of Barangay Cabuliban, this city, for review action as mandated by Section 57 of the Local Government Code of 1991;

WHEREAS, upon the review made on said ordinance, this august Body has observed that said ordinance is defective as the public hearing was done only on August 17, 1997 after it was enacted on August 03, 1997, contrary to the provision of Section 187 of the Local Government Code of , 1991 which provides:

"Sec. 187. Procedure for approval and effectivity of Ordinance and Revenue Resources; Mandatory Public Hearing. The procedure for approval of local tax ordinances and revenue measures shall be in accordance with the provisions of this Code: Provided, That public hearing shall be conducted for the purpose PRIOR the enactment thereof.

WHEREFORE, foregoing premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, seconded by mga Kagawad Deborah Robin B. Conejos and Benjamin B. Lladoc;

RESOLVED, to pass a resolution RETURNING TO THE SANGGUNIANG BARANGAY OF BARANGAY CABULIHAN, THIS CITY, ITS BARANGAY TAX ORDINANCE NO. 01 S. 1997, ENTITLED, "AN ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS, SIGNBOARD, BILLBOARDS, OTHER OUTDOOR ADVERTISEMENTS, CERTIFICATIONS, BARANGAY CLEARANCE AND BARANGAY PERMITS;
