## RESOLUTION NO. 97-170

RESOLUTION EXHORTING THE OFFICIALS AND PERSONNEL OF THE CITY LICENSING AND PERMIT DIVISION, THIS CITY, TO STRICTLY COMPLY WITH THE PROVISIONS OF SECTION 23. PARAGRAPH (G) OF REPUBLIC ACT 8282, OTHERWISE KNOWN AS THE SOCIAL SECURITY ACT OF 1997".

WHEREAS, on September 16, 1996, a Memorandum of Agreement (MOA) was entered into by and between the DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT and the SOCIAL SECURITY SYSTEM, wherein it was agreed among others, that LGUs shall require employers to present their SSS clearance before issuing/renewing their business licenses/permits;

WHEREAS, the aforestated requirement is now embodied in Section 23, paragraph (g) of Republic Act 8282, otherwise known as the "Social Security Act of 1997" which was approved on May 1, 1997, to wit:

Notwithstanding any law to the contrary, local government units shall, prior to issuing any annual business license or permit, require submission of certificate of SSS coverage and compliance with the provisions of this Act: Provided, That the certification or clearance shall be issued by the SSS within five (5) working days from receipt of the request";

WHEREAS, Section 28, Penal Clause of the aforecited law, paragraph (e) thereof provides:

"(e) Whoever fails or refuses to comply with the provisions of this Act or with the rules and regulations promulgated by the Commission, shall be punished by a fine of not less than Five Thousand Pesos (\$5,000.00) nor more than Twenty Thousand Pesos (\$20,000.00), or imprisonment for not less than six (6) years and one (1) day nor more than twelve (12) years, or both, at the discretion of the Court.";

WHEREAS, to obviate the penal liability of the aforementioned law, it is imperative that our officials and employees involved in the issuance of business license or permit be cautioned to faithfully observe the aforecited requirements of the SS Law;

WHEREFORE, foregoing premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, severally seconded by mga Kagawad Fernando P. Parrilla, Sotero M. Pepito and Benjamin B. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to adopt a resolution exhorting the officials and personnel of the City Licensing and Permit Division, this city, to strictly comply with the provisions of Section 23, paragraph (g) of Republic Act 8282, otherwise known as "the Social Security Act of 1997";
