Committee on Finance, duly seconded by Kagawad Benjamin B. Lladoc; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to approve the 1997

ENACTED, September 25, 1997.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
