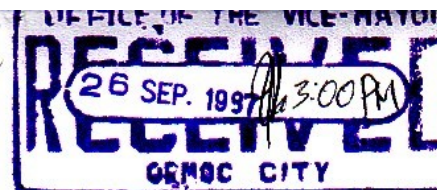
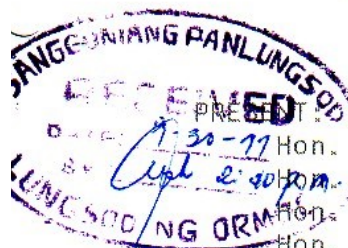

WHEREAS, this Sanggunian is in receipt of sisters Resolutions Nos.
2 and 3, both series of 1997 from the City Development Council (CDC),
this city, entitled:
