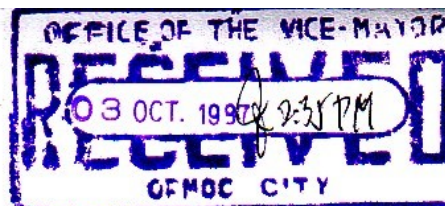
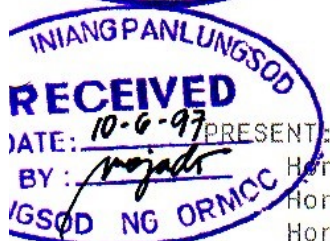


RESOLVED, AS IT IS HEREBY RESOLVED, to approve the 1997 Supplemental Budget No. 01 of Barangay District 01, this city;

ENACTED, October 2, 1997.


