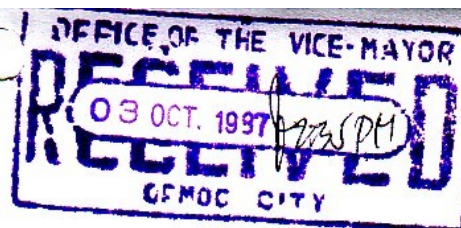

Sotero M. Pepito and Deborah Robin B. Conejos; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to approve the 1997 Supplemen-

ENACTED, October 2, 1997.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
