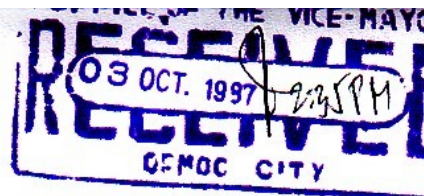

ENTITLED, "A RESOLUTION APPROVING THE SUSPENSION OF
KAGAWAD MARIO CALAPE OF BARANGAY TAMBULILID OF NOT MORE
THAN AND LESS THAN ONE (1) MONTH", FOR HIS APPROPRIATE
ACTION IN LINE WITH RESOLUTION NO. 99 SERIES OF 1992 OF

WHEREAS, this Sanggunian is in receipt of Resolution No. 28 s. 1997
of Barangay Tambulilid, this city, entitled, "A RESOLUTION APPROVING THE
SUSPENSION OF KAGAWAD MARIO CALAPE OF BARANGAY TAMBULILID OF NOT MORE
THAN AND LESS THAN ONE (1) MONTH";

WHEREAS, as stated in said Barangay Resolution, Kagawad Mario
Calape of Barangay Tambulilid, this city, has allegedly committed the
following acts:

1. Dereliction of Duty
