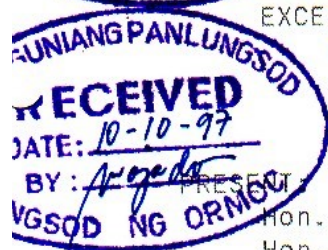
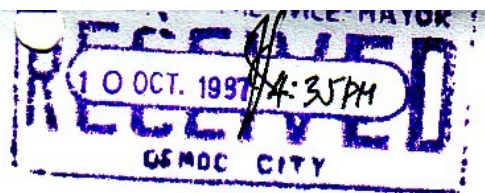

BY RESOLUTION NO. 96-215 DATED NOVEMBER 14, 1996, TO
SUBMIT SOONEST ITS LONG OVERDUE REPORT AND
RECOMMENDATION ON THE ACTUAL AND FUTURE USE OF THE
GOVERNMENT CENTER SITUATED AT BRGY. COGON, THIS CITY.

WHEREAS, this Sanggunian passed Resolution No. 96-141 as amended by
Resolution No. 96-215 creating a committee to study and to recommend to
this Sanggunian, the actual and future use of the Government Center
situated at Brgy. Cogon, this city, composed of the following: Mrs.
