RESOLUTION NO. 97-191

A RESOLUTION RESPECTFULLY REQUESTING HIS EXCELLENCY
PRESIDENT FIDEL V. RAMOS FOR A PRESIDENTIAL
PROCLAMATION DECLARING OCTOBER 20, 1997 A NON-WORKING
HOLIDAY FOR ORMOC CITY, IT BEING ITS 50TH CHARTER DAY
ANNIVERSARY.

WHEREAS, the Second Sangguniang Panlungsod ng Ormoc passed
Resolution No. 266 dated August 19, 1980 embodying Ordinance No. 25
entitled, "AN ORDINANCE DESIGNATING OCTOBER 20 EVERY YEAR AS ORMOC CITY
CHARTER DAY";

WHEREAS, His Excellency, the late President Manuel Roxas pursuant
to the provisions of Republic Act No. 179, otherwise known as the
Charter of Ormoc City, fixed October 20, 1947 as the date for the
Inauguration of Ormoc City through Presidential Proclamation No. 42
dated September 4, 1947;

WHEREAS, as a Chartered City for fifty (50) years, Ormoc is proud
to be what she is today; from the ravages of the last war to the
threshold of progress and prosperity brought about by the untiring
efforts of the Ormocanons through its public officials who in one way or
another helped propel the city towards new horizons;

WHEREAS, as a fitting tribute to its existence and instill into the
minds of the Ormocanons of its humble beginning to its present status,
this august Body believes that said date be given meaning and
importance, hence, this request;

WHEREFORE, foregoing premises considered, on MASS MOTION of the
Body and with OVERWHELMING SECONDS; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution respectfully requesting His Excellency President Fidel V. Ramos for a Presidential Proclamation declaring October 20, 1997 a Non-working Holiday for Ormoc City, it being its 50th Charter Day Anniversary;

ENACTED, October 9, 1997.

RESOLVED, FURTHER, to furnish copies of this resolution, one each, to His Excellency, Fidel V. Ramos, President, Republic of the Philippines, Malacañang Palace, Metro Manila; to His Honor, the City Mayor of Ormoc, Eufrocino M. Codilla, Sr.; the City Administrator, the City Treasurer and other offices concerned, -in Ormoc City;
