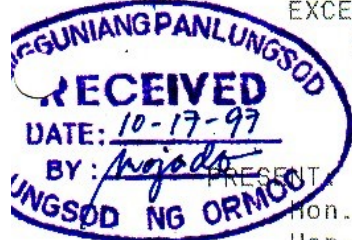
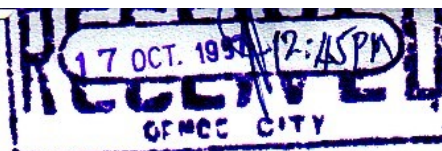

RESOLUTION NO. 97-195

A RESOLUTION RETURNING TO THE SANGGUNIANG BARANGAY OF NASUNOGAN, THIS CITY, THEIR TAX ORDINANCE NO. 97-14, SERIES OF 1997, ENTITLED: "AN ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS, BILLBOARDS, SIGNBOARDS, PREVAILEGE (SIC) PANELS, AND OTHER OUTDOOR ADVERTISEMENTS, BARANGAY CLEARANCE AND BARANGAY PERMITS" AND TAX ORDINANCE NO. 01, SERIES OF 1997, ENTITLED: "AN ORDINANCE CHARGING A FEE ON THE USE OF THE BARANGAY BASKETBALL COURTS OR OF ANY PORTION OF THE BARANGAY MULTI-PURPOSE PAVEMENTS FOR DRYING GRAINS AND SIMILAR MATERIALS" FOR THE REASONS STATED HEREUNDER.

WHEREAS, this Sanggunian is in receipt from the Sangguniang Barangay of Nasunogan, this City, their Tax Ordinance No. 97-14, Series of 1997, entitled: "An Ordinance imposing taxes on stores or retailers, billboards, signboards, prevailege (SIC) panels, and other outdoor advertisements, barangay clearance and barangay permits" and Tax Ordinance No. 01, Series of 1997, entitled: "An Ordinance charging a fee on the use of barangay basketball courts or of any portion of the barangay multi-purpose pavements for drying grains and similar materials" submitted for review as mandated by Article III of the Rules and Regulations Implementing the Local Government Code of 1991;

WHEREAS, a review of the aforementioned Ordinances revealed that they are defective as shown hereunder;

WHEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, duly seconded by Kagawad Claudio P. Larrazabal; be it-

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution returning to the Sangguniang Barangay of Nasunogan, this City, their Tax Ordinance No. 97-14, Series of 1997, entitled: "AN ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS, BILLBOARDS, SIGNBOARDS, PREVAILEGE (SIC) PANELS, AND OTHER OUTDOOR ADVERTISEMENTS, BARANGAY CLEARANCE AND BARANGAY PERMITS", and Tax Ordinance No. 01, Series of 1997, entitled: "AN ORDINANCE CHARGING A FEE ON THE USE OF THE BARANGAY BASKETBALL COURTS OR OF ANY PORTION OF THE BARANGAY MULTI-PURPOSE PAVEMENTS FOR DRYING GRAINS AND SIMILAR MATERIALS" for the reasons stated hereunder, to wit:

1. That both Tax Ordinances were enacted without any prior public hearing conducted for the purpose as required in Article 274 of RRILGC.

The Certification contained in both tax ordinances is to the effect that the public hearing was conducted for the purpose of promulgating the Ordinance.

The conduct of the public hearing is governed by the procedure in Article 276, par. (b) of the RRILGC.

2. That the date of approval of Tax Ordinance No. 97-14 as indicated therein is JULY 22, 1997 which does not jibe with the date of its enactment on July 20, 1997, hence questionable.

ENACTED, October 16, 1997.

RESOLVED, FURTHER, to furnish copies of this Resolution, one each to - The Sangguniang Barangay of Nasunogan, through its Punong Barangay and Presiding Officer; the Honorable City Mayor of Ormoc, Eufrocino M. Codilla, Sr.; the President, Association of Barangay Councils; Office of Barangay Affairs; Local Office of D I L G, and other offices concerned.
