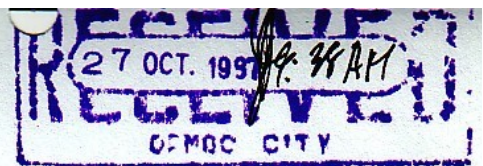

RESOLUTION NO. 97-199

A RESOLUTION ENDORSING TO THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), TACLOBAN CITY, THE ATTACHED COPY OF THE RESOLUTION OF SANGGUNIANG BARANGAY OF MACABUG, THIS CITY, ENTITLED: "A RESOLUTION REQUESTING DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES TO DISAPPROVE ANY PRIVATE APPLICANT CLAIMANT FOR OWNERSHIP OF PUBLIC LANDS LOCATED ALONG SHORELINE AND ANY OTHER SITES UNDER THE JURISDICTION OF BARANGAY MACABUG, ORMOC CITY"; WITH THE REQUEST THAT THE SAME BE ACTED FAVORABLY.

WHEREAS, this Sanggunian is in receipt of a copy of the resolution of the Sangguniang Barangay of Macabug, this city, entitled: "A RESOLUTION REQUESTING DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES TO DISAPPROVE ANY PRIVATE APPLICANT CLAIMANT FOR OWNERSHIP OF PUBLIC LANDS LOCATED ALONG SHORELINE AND ANY OTHER SITES UNDER THE JURISDICTION OF BARANGAY MACABUG, ORMOC CITY" copy of which is hereto attached for ready reference;

WHEREAS, the Brgy. Macabug Fish Sanctuary being one of the most successful Fish Sanctuaries in Region VIII and which has revitalized the marine life and ecosystem of the area, has to be protected from possible degradation;

WHEREAS, this Sanggunian fully subscribes to the noble purposes and objectives of the aforementioned resolution, and for the attainment thereof, suggests and recommends to the Sangguniang Barangay of Macabug that they file the appropriate application with the Department of Environment and Natural Resources, Tacloban City, for the use of the Barangay the particular public land;

WHEREFORE, foregoing premises considered, on MASS MOTION of the Body and with OVERWHELMING SECONDS; be it

RESOLVED, to pass a resolution ENDORSING TO THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), TACLOBAN CITY, THE ATTACHED COPY OF THE RESOLUTION OF SANGGUNIANG BARANGAY OF MACABUG, THIS CITY, ENTITLED: "A RESOLUTION REQUESTING DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES TO DISAPPROVE ANY PRIVATE APPLICANT CLAIMANT FOR OWNERSHIP OF PUBLIC LANDS LOCATED ALONG SHORELINE AND ANY OTHER SITES UNDER THE JURISDICTION OF BARANGAY MACABUG, ORMOC CITY"; WITH THE REQUEST THAT THE SAME BE ACTED FAVORABLY;
