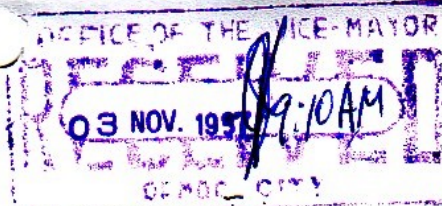

RESOLUTION NO. 97-201

A RESOLUTION INFORMING MR. JORGE P. TAN, JR., RELATIVE TO  
HIS LETTER DATED APRIL 29, 1997, THAT THE PORTION OF  
LOT NO. 2439 OCCUPIED BY HIM, AND LOT NO. 2440 ARE  
OUTSIDE THE HIGH RISK AREA AS DEFINED IN ORDINANCE NO.  
37; HOWEVER, LOT NO. 2438, AND LOT NO. 2441 (NOW LOT  
NOS. 6, 7 & 8) ARE WITHIN THE HIGH RISK AREA, AND STILL  
CONSIDERED AS SUCH, HENCE CANNOT BE EXEMPTED FROM THE  
COVERAGE OF ORDINANCE NO. 37, OTHERWISE KNOWN AS THE  
HIGH RISK ORDINANCE.

WHEREAS, the letter dated April 29, 1997 of Mr. Jorge P. Tan, Jr.,  
requesting for the exemption of his properties located at Brgy. Batuan  
(formerly Alegria), this City, from the coverage of Ordinance No. 37,  
otherwise known as the High Risk Ordinance, was on September 30, 1997,  
endorsed by the Honorable City Mayor, Eufrocino M. Codilla, Sr., to this  
Sanggunian for appropriate action;

WHEREAS, the aforementioned letter of Mr. Tan, Jr., was endorsed to  
Tax Mapper IV, Engr. Darlito Pareja for verification and investigation,  
and to submit his findings and recommendations thereto;

WHEREAS, on October 15, 1997, Engr. Darlito A. Pareja submitted his  
findings and recommendations, contained in his 4th Indorsement, copy of  
which is hereto attached for ready reference;



WHEREAS, the investigation and findings of Engr. Pareja disclosed the following relevant facts, to wit:

- 1) That the portion of Lot No. 2439 occupied by Mr. Jorge P. Tan, Jr., and Lot No. 2440 are outside the High Risk Area as defined in Ordinance No. 37, hence the request for its exemption from the coverage of Ordinance No. 37 is not necessary;
- 2) That Lot No. 2438 and Lot No. 2441 (now Lot Nos. 6, 7 & 8) are within the High Risk Area and still considered presently as such, consequently cannot be exempted from the coverage of Ordinance No. 37;

WHEREFORE, foregoing premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, and Laws and Ordinances, jointly seconded by mga Kagawad Claudio P. Larrazabal and Alfredo F. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution informing Mr. Jorge P. Tan, Jr., relative to his letter dated April 29, 1997, that the portion of Lot No. 2439 occupied by him, and Lot No. 2440 are outside the high risk area as defined in Ordinance No. 37; however, Lot No. 2438, and Lot No. 2441 (now Lot Nos. 6, 7 & 8) are within the high risk area, and still considered as such, hence cannot be exempted from the coverage of Ordinance No. 37, otherwise known as the High Risk Ordinance;

ENACTED, October 30, 1997.

RESOLVED, FURTHER, to furnish copies of this resolution, one each to Mr. Jorge P. Tan, Jr., the Honorable City Mayor, Eufrocino M. Codilla, Sr., the City Administrator, Mr. Vicente Redoña, the City Legal Officer, Atty. Cleto L. Evangelista, Jr., the Office of the City Register of Deeds; the Office of the City Assessor, the Office of the City Treasurer, and other Offices concerned.
