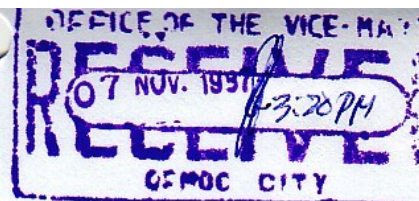

Committee on Finance, duly seconded by Kagawad Benjamin B. Lladoc; be it


RESOLVED, to pass a resolution APPROVING THE 1997 SUPPLEMENTAL
