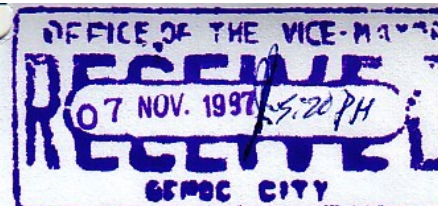

BUDGET NO. 02 OF BARANGAY DISTRICT 23, THIS CITY;



Chairman/Treasurer of Barangay District 23, -all in Ormoc City;


