TIM REQUESTING THE BOARD OF DIRECTORS OF LEYECO A STUDY AND PROPOSAL FOR PREFERENTIAL RATES THOUSTRIAL AND COMMERCIAL CONSUMERS IN ORMOC CITY AND TO FURNISH THIS SANGGUNIAN A COPY OF THE RESULT OF NEIR STUDY AND PROPOSAL.

WHEREAS, electric consumers in the area of coverage of LEYECO V as as the whole of Region VIII are onerously suffering from the very igh electric rates as compared in other regions despite the fact that he geothermal plants are located in Leyte, more particularly in Kananga Ormoc City;

WHEREAS, would-be foreign investors are shying away from Region VIII because of the very high electric rates;

WHEREAS, Ormoc City is the site of the Provincial Industrial Center and which may be operational by early of year 1998 and in order to make it competive and attractive to investors, a preferential rate for industrial uses is necessary;

WHEREAS, during one of the meetings of the Committee on Energy Development & Conservation, it was learned that LEYECO V has not yet come out with a proposed preferential rates for industrial consumers;

NOW, THEREFORE, premises considered, on motion of Kagawad Gregorio Yrastorza, Jr., Chairman, Committee on Energy Development Conservation severally seconded by mga Kagawad Claudio P. Larrazabal, Benjamin B. Lladoc and Deborah Robin B. Conejos; be it

RESOLVED, to pass a resolution REQUESTING THE BOARD OF DIRECTORS OF LEYECO V TO MAKE A STUDY AND PROPOSAL FOR PREFERENTIAL RATES FOR INDUSTRIAL AND COMMERCIAL CONSUMERS IN ORMOC CITY AND TO FURNISH THIS SANGGUNIAN A COPY OF THE RESULT OF THEIR STUDY AND PROPOSAL;
