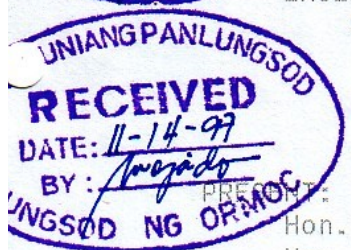
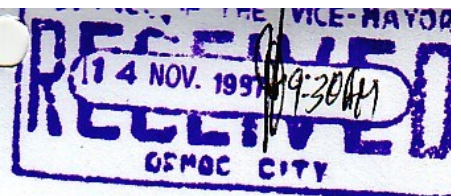



ENACTED, November 12, 1997.


