RESOLUTION NO. 97-215

RESOLUTION AUTHORIZING THE HONORABLE CITY EUFROCINO CODILLA, SR., TO SIGN, FOR AND IN BEHALF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE ORMOC MATERNITY HOUSE AND CHILDRENS' HOSPITAL, REPRESENTED BY ITS PRESIDENT, DR. IMMANUEL M. PENARANDA.

EREAS, this Sangguniang is in receipt of 1st Indorsement dated 3 November 1997 from the Honorable City Mayor Eufrocino M. Codilla, Sr., requesting for the passage of a resolution authorizing the former to sign for and in behalf of the City Government of Ormoc the Memorandum of Agreement by and between the City Government of Ormoc and the Ormoc Maternity House and Childrens' Hospital for the latter to use the lot as LESSEE for and in consideration of a token/or minimal rental in the sum of TWELVE THOUSAND PESOS (P12,000.00) a year, starting January 1998 for a period of TWENTY (20) years thereafter;

WHEREAS, the 7th Sangguniang Panlungsod ng Ormoc in SESSION, has considered said request reasonable, hence must be given due course of action;
