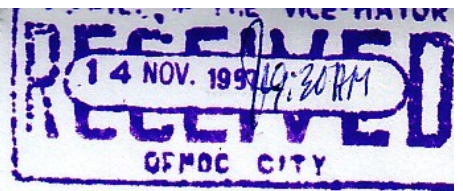

RESOLUTION NO. 97-216

A RESOLUTION REQUESTING NEA ADMINISTRATOR, TEODORICO P. SANCHEZ, FOR AN UPDATE ON THE ACTIONS TAKEN OVER THE NEA AUDIT INVESTIGATION CONDUCTED AT LEYECO V ON THE PURCHASE OF 10 MVA POWER TRANSFORMER SUBSTATION (PTS).

WHEREAS, the result of an audit investigation conducted by a NEA Investigation Team at LEYECO V of the 10 MVA Power Transformer Substation (PTS) purchased by LEYECO V from PEAM was submitted to the NEA Administrator, Teodorico P. Sanchez with their corresponding recommendations last 20 January 1997;

WHEREAS, in response to SP Resolutions No. 97-30 and 97-31 dated 20 February 1997 requesting the NEA to place under preventive suspension of some of the officials/employees of LEYECO V involved in the audit report conducted by NEA, NEA informed this august Body that NEA's audit findings is not a conclusive proof of the respondents' guilt and that due process should be accorded to them and further, that NEA will keep this Sanggunian informed of the development of this case;

WHEREAS, up to the present date, no further communications were received by this Sanggunian from NEA as to the development of NEA's audit investigation;

WHEREAS, this Sanggunian would greatly appreciate it very much to know if there are any new developments on NEA's investigation;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., Chairman, Committee on Energy Development & Conservation, duly seconded by Kagawad Benjamin B. Lladoc; be it




