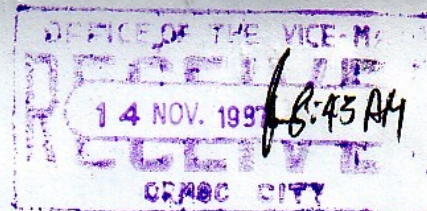
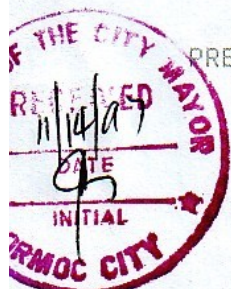

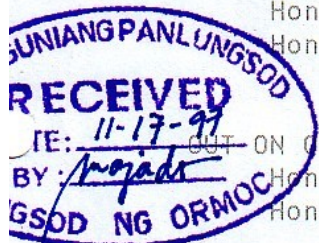


EXCERPT FROM THE MINUTES OF THE REGULAR SESSION OF THE SEVENTH

RESOLUTION NO. 97-217

A RESOLUTION AUTHORIZING CITY LEGAL OFFICER, ATTY. CLETO L. EVANGELISTA, JR. TO FILE THE APPROPRIATE LEGAL ACTION WITH THE PROPER COURT FOR THE SETTLEMENT OF THE BOUNDARY DISPUTE BETWEEN THE MUNICIPALITY OF KANANGA, LEYTE AND THE CITY OF ORMOC, AND TO APPRISE IMMEDIATELY THIS SANGGUNIAN OF ANY IMPORTANT DEVELOPMENT THEREOF.

WHEREAS, this Sanggunian has exerted its utmost efforts to settle amicably with justice and fairness the long pending boundary dispute between the Municipality of Kananga, Leyte and the City of Ormoc in conformity with the policy enunciated in the Local Government Code of 1991 specifically Section 118 thereof concerning the settlement of boundary disputes between or among LGUs;

WHEREAS, on October 31, 1997, upon the initiative of this Sanggunian, the two (2) Sanggunians of the Municipality of Kananga, Leyte and the City of Ormoc met for the purpose of settling their boundary dispute, but very unfortunately, they could not reconcile their respective positions on the matter; hence, they agreed to pass a resolution, entitled: "A RESOLUTION CERTIFYING THAT BOTH THE SANGGUNIANG PANLUNGSOD OF ORMOC CITY AND THE SANGGUNIANG BAYAN OF KANANGA, LEYTE HAVE FAILED TO SETTLE AMICABLY THEIR BOUNDARY DISPUTE AND HAVE AGREED TO ELEVATE THE SAME TO THE PROPER COURT FOR SETTLEMENT BY THE INTERESTED PARTY"; (A Photocopy of which is hereto attached for ready reference)

FOREGOING PREMISES CONSIDERED, on motion of Kagawad Mariano Y. Corro, Chairman, Committees on Public Properties, and Laws and Ordinances, duly seconded by Kagawad Fernando P. Parrilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution authorizing the City Legal Officer, Atty. Cleto L. Evangelista, Jr. to file the appropriate legal action with the proper court for the settlement of the boundary dispute between the Municipality of Kananga, Leyte and the City of Ormoc, and to apprise immediately this Sanggunian of any important development thereof;
