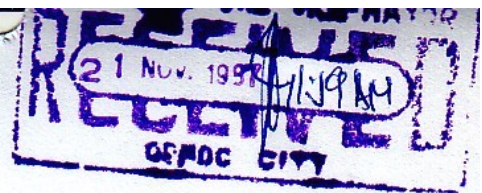
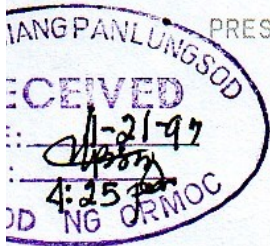

RESOLUTION NO. 97-222

A RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE CITY MAYOR, EUDOCINO M. CODILLA, SR. TO TAKE THE NECESSARY APPROPRIATE STEPS TO COMPEL TAI-PAN DEVELOPMENT, INC., OPERATOR OF THE ORMOC CITY SHOPPING MALL, TO COMPLY WITH ITS OBLIGATION IN PAYING THE PREMIUMS ON THE FIRE INSURANCE POLICY OF THE ORMOC CITY SHOPPING MALL TO THE GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS) TACLOBAN CITY BRANCH.

WHEREAS, this Sanggunian has been furnished a copy of the letter dated November 5, 1997 of the Government Service Insurance System (GSIS) Tacloban City Branch, addressed to Mr. Edmund S. Gaisano of Tai-Pan Development, Incorporated, anent the non-renewal of the Fire Policy on the Ormoc City Shopping Mall for non-payment of premiums covering the period, December 8, 1995 to April 19, 1997;

WHEREAS, the Memorandum of Agreement entered into by the City Government of Ormoc and Tai-Pan Development Incorporated on the operation of the Ormoc City Shopping Mall, obliged Tai-Pan Development Incorporated to pay the premiums on the insurance of the Ormoc City Shopping Mall with the City Government of Ormoc as the Insured;

WHEREAS, the non-payment of the insurance premiums by Tai-Pan Development Incorporated is a violation of the aforementioned Memorandum of Agreement, and will likewise greatly prejudice the City Government of Ormoc if and when the Ormoc City Shopping Mall is destroyed due to the perils insured against;



WHEREAS, it is the duty and obligation of the City Officials of Ormoc to see to it that the properties of the City Government are amply protected, and that contracts entered into by the City Government are faithfully complied with by the parties thereto;

WHEREFORE, in consideration of the foregoing premises, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, severally by mga Kagawad Benjamin B. Lladoc, Sotero M. Pepito, Alfredo F. Capahi and Chiqui B. Labagala; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RESPECTFULLY REQUESTING THE HONORABLE CITY MAYOR, EUFROCINO M. CODILLA, SR.
