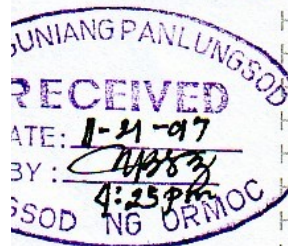

A RESOLUTION APPROVING TAX ORDINANCE NO. 01 SERIES OF 1997 OF THE BARANGAY COUNCIL OF NASUNOGAN, THIS CITY, ENTITLED: "AN ORDINANCE CHARGING A FEE ON THE USE OF THE BARANGAY BASKETBALL COURTS OR OF ANY PORTION OF THE BARANGAY MULTI-PURPOSE PAVEMENTS FOR DRYING GRAINS AND SIMILAR MATERIALS" AND TAX ORDINANCE NO. 02 SERIES OF 1997, ENTITLED: "AN ORDINANCE IMPOSING TAXES ON STORES OR RETAILERS, BILLBOARDS, SIGNBOARDS, PRIVELEGE (SIC) PANELS AND OTHER OUTDOOR ADVERTISEMENTS, BARANGAY CLEARANCES AND BARANGAY PERMITS".


