RESOLUTION NO. 98-11

RESOLUTION GRAPTING SOCIAL ACCEPTABILITY TO THE RICE MILL OF JAIME GABAS LOCATED AT SITIO VILDINOMO, LIBERTAD, DRMOC CITY, BASED ON THE PUBLIC CONSULTATION AND RESOLUTION OF THE BARANGAY ACCEPTING THE SAME.

WHEREAS, this Sanggunian is in receipt of a letter dated 3 July 1998 from Mr. Jaime Gabas, owner, Gabas Rice Mill, requesting for a resolution of social acceptability of said rice mill project, located at Sitio Vildinomo, Brgy. Libertad, this city;

WHEREAS, same Mr. Jaime Gabas, has applied for the issuance of an Environmental Compliance Certificate with the Department of Environment and Natural Resources (DENR) relative to his application for the operation of a rice mill in said place;

WHEREAS, upon proper consultation with the residents of Barangay Libertad, this city, said rice mill is socially accepted as manifested by the Barangay Council of said barangay through a resolution dated 21 June 1998, Resolution No. 02 s. 1998 entitled, "A RESOLUTION SOCIALLY ACCEPTING GABAS RICE MILL AS ENVIRONMENT FRIENDLY AND POLLUTION FREE ESTABLISHMENT";
