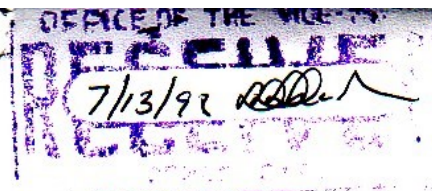

EFFECTIVE JULY 1, 1998.

WHEREAS, of importance to state in here are the following
provisions of Republic Act No. 7160 otherwise known as the Local
Government Code of 1991:

"Sec. 481, 2nd Par. The term of the (City) Legal Officer shall
be coterminous with that of the appointing authority."

"Sec. 480. 2nd Par. The term of the (City) Administrator is coterminous with that of the appointing authority."

"Sec. 454. Par. (d). X X X heads of departments and offices shall be appointed (re-appointed) by the City Mayor with the concurrence of the majority of all the Sangguniang Panlungsod members, subject to Civil Service laws, rules and regulations. The Sangguniang Panlungsod shall act on the appointment (re-appointment) within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed."

WHEREAS, foregoing premises considered, on motion of Kagawad Jose S. Serafica, Floor Leader, severally seconded by Kagawad Benjamin B. Lladoc, Chiqui B. Labagala, Mariano Y. Corro, Sotero M. Pepito, Eduardo P. Tan and Fernando P. Parrilla; be it

RESOLVED, to pass a resolution CONCERNING THE REAPPOINTMENTS AND PROMOTIONAL APPOINTMENT OF ATTY. CLETO L. EVANGELISTA, MR. VICENTE V. REDONA AND ENGR. ANTONIO Z. PADAYAO AS CITY LEGAL OFFICER, CITY ADMINISTRATOR AND CITY ENGINEER OF THE CITY GOVERNMENT OF ORMOC, RESPECTIVELY, EFFECTIVE JULY 1, 1998;
