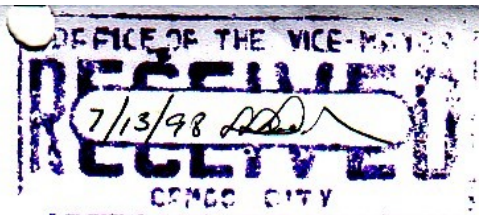
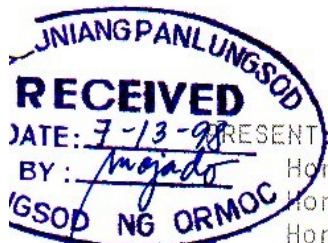

Aparis, I, Chiqui B. Labagala and Sotero M. Pepito; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution ADOPTING

ADOPTED, July 09, 1998.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
